### APPLICATION FOR KENNEL LICENSE

#### INTRODUCTION

New Applications - All individuals wanting to operate a kennel in the Township of Mapleton must complete the following application for approval and pay the required fee. Township staff will review your application to ensure that all information has been completed. Once the application has been reviewed, we will determine whether the property is properly zoned to allow a kennel in accordance with the Township's Zoning By-law. Should the property not be properly zoned, the property owner must apply for a zone amendment in order to proceed further. Following the completion of an approved zone amendment, the Township's Canine Control Officer will contact the property owner to conduct an inspection of the property. No kennel license shall be granted unless all terms and provisions of the Township's by-law to license and regulate dogs and dog kennels have been complied with. A detailed Site Plan drawing must be submitted with the application showing the location and separating distances of all buildings on the property and the proposed location of the kennel including fencing, pens, etc. This site drawing is to be dated and signed.

Renewal Applications - All existing licensed kennel owners must apply each year to renew their license. No kennel license shall be renewed unless all terms and provisions of the Township's By-law to license and regulate dogs and dog kennels have been complied with and the kennel license fee has been paid. With the renewal application, a detailed site drawing showing the location and separating distances of all buildings on the property and the location of the kennel including fencing, pens, etc. must be submitted. This site drawing is to be dated and signed.
